Be it enacted by the NIAGARA COUNTY LEGISLATURE of the

1. The salary of the County Treasurer shall be increased in the sum of \$850.00 effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the County Treasurer shall be \$16,850.00.
2. The salary of the Public Defender shall be increased in the sum of \$438.00, effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the Public Defender shall be \$12,438.00.
3. The salary of the Commissioner of Social Services shall be increased in the sum of \$525.00, effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the Commissioner of Social Services shall be \$19,525.00.
4. The salary of the County Attorney shall be increased in the sum of \$540.00, effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the County Attorney shall be \$17,040.00.
5. The salary of the Commissioner of Jurors shall be increased in the sum of \$158.00, effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the Commissioner of Jurors shall be \$5,158.00.
6. The salary of the Commissioners of Election shall be increased in the sum of \$493.00 effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the Commissioners of Election shall be \$10,493.00.
7. The salary of the Probation Director shall be increased in the sum of \$539.00, effective 45 days after adoption of this Local Law. Effective January 1, 1974, the annual salary of the Probation Director shall be \$16,361.00.
