A local law amending Local Law No. 2 of the year 1970, "Article 3 - Membership of the Environmental Management Council (Insert title)

Be it enacted by the Niagara County Legislature of the (Name of Legislative Body)

~~Village~~ Article 3 - Membership of the Niagara County Environmental Management Council shall be amended as follows:

3. Membership: The Council shall be composed of twenty-one (21) members, one from each Town, one from each City, and one from each Village within the County, to be appointed by the Chairman of the Niagara County Legislature, subject to confirmation by the County Legislature, and five (5) ex-officio members. One of the appointive members shall be designated by the Chairman of the Legislature as chairman of the Council. The ex-officio members shall be the Commissioner of Health, the Director of the Economic Development and Planning Commission, the Superintendent of Highways, the County Attorney, the Director of the Niagara County Extension Service, and a representative of the Niagara County Federation of Sportsmen. As far as may be practicable, members of the Council shall be selected from the field of Local Governments in the County, groups or associations interested in conservation and environmental affairs, and other citizens of the county.

This local law shall take effect immediately.




