A local law for the County of Niagara, New York, revising the Coroners' District Boundaries (insert title)

Be it enacted by the Niagara County Legislature of the (Name of Legislative Body)

That the County of Niagara be and is hereby divided into four districts as follows;

First District: To be composed of the territory included within the limits of the City of Niagara Falls.

Second District: To be composed of the territory included within the limits of the City of North Tonawanda and the Towns of Wheatfield and Pendleton.

Third District: To be composed of the territory included within the limits of the City of Lockport and the Towns of Lockport, Royalton, Hartland and Somerset.

Fourth District: To be composed of the territory included within the limits of the Towns of Porter, Wilson, Newfane, Lewiston, Cambria and Niagara.

There shall be elected one coroner from each such district upon the general election day to be held in the year 1978 and every third year thereafter each of whom shall have jurisdiction to perform the duties of the office anywhere within the territorial limits of said County.

This Local Law shall become effective 45 days after its adoption.


