Local Law No. 3 of the year 19 79

A local law amending Local Law #2-1979, increasing the salaries of certain county officials

Be it enacted by the Legislature of the

County
City of Niagara
Town
Village as follows:

1. Paragraph 11 of Local Law #2-1979 for the County of Niagara shall be deleted in its entirety.
2. The following paragraph shall be inserted as Paragraph 11 of Local Law #2-1979 for the County of Niagara:
 "11. The salary of the Director of Real Property Tax Services shall be increased in the sum of \$1,445, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 9, 1979, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactively to April 9, 1979, the annual salary of the Director of Real Property Tax Services shall be \$16,500."
3. This Local Law shall become effective 45 days after the adoption of same.
