The salary of the County Treasurer shall be increased in the sum of \$5,729, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1980, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactively to January 1, 1980, the annual salary of the County Treasurer shall be \$28,000.

This Local Law shall become effective 45 days after the adoption of same.
