A local law increasing the salaries of certain County officials

Be it enacted by the Niagara County Legislature of the

1. The salary of the County Attorney shall be increased in the sum of \$1,624 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985 and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the County Attorney shall be \$34,099.

2. The salary of the Commissioners of Election shall be increased in the sum of \$1,017, each, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactively to January 1, 1985, the annual salary of the Commissioners of Election shall be \$21,349, each.

3. The salary of the Public Defender shall be increased in the sum of \$1,194 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Public Defender shall be \$25,074.

4. The salary of the Probation Director shall be increased in the sum of \$1,549 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Probation Director shall be \$32,525

5. The salary of the County Auditor shall be increased in the sum of \$1,195 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the County Auditor shall be \$25,088.

6. The salary of the Purchasing Agent shall be increased in the sum of \$1,224 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Purchasing Agent shall be \$25,697.

7. The salary of the Commissioner of Parks & Recreation shall be increased in the sum of \$1,427 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Commissioner of Parks & Recreation shall be \$29,973.

8. The salary of the Commissioners of Civil Service shall be increased in the sum of \$165.00 each, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Commissioners of Civil Service shall be \$3,467, each.

9. The salary of the Director of Real Property Tax Services shall be increased in the sum of \$1,121 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Director of Real Property Tax Services shall be \$23,540.

10. The salary of the Commissioner of Social Services shall be increased in the sum of \$2,077 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1985, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1985, the annual salary of the Commissioner of Social Services shall be \$43,612.
