1. The salary of J. Joyce, District #1, shall be increased from \$19,159 to \$19,272 per year commencing 1/1/91 through 12/31/91.

2. The salary of A. Flessel, District #2, shall be increased from \$9,579 to \$14,200 per year commencing 1/1/91 through 12/31/91.

3. The salary of K. Lederhouse, District #3, shall be increased from \$6,158.25 to \$9,926 per year commencing 1/1/91 through 12/31/93.

4. The salary of K. Sherrie, District #4, shall be increased from \$9,579.50 to \$13,113 per year commencing 1/1/91 through 12/31/91.

This Local Law shall become effective within 45 days, during which time said Local Law is subject to a permissive referendum.
