Local Law No. 1 of the year 19 93

A local law INCREASING THE SALARIES OF CERTAIN COUNTY OFFICIALS

Be it enacted by the NIAGARA COUNTY LEGISLATURE of the

as follows:

1. The Salary of the County Attorney shall be increased in the sum of \$1,449, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the County Attorney shall be \$47,366.

2. The Salary of the Commissioners of Election shall be increased in the sum of \$901 each, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Commissioners of Election shall be \$34,398 each.

3. The salary of the Public Defender shall be increased in the sum of \$945, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Public Defender shall be \$35,638.

4. The salary of the Probation Director shall be increased in the sum of \$1,285, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Probation Director shall be \$45,864.

5. The salary of the Commissioner of Parks and Recreation shall be increased in the sum of \$1,310, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past service rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Commissioner of Parks and Recreation shall be \$45,864.

6. The salary of the Commissioners of Civil Service shall be increased in the sum of \$164 each, effective 45 days after adoption of this Local Law with a lump sum installments to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Commissioners of Civil Service shall be \$6,259 each.

7. The salary of the Director of Real Property Tax Services shall be increased in the sum of \$1,487 effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Director of Real Property Tax Services shall be \$38,048.

8. The salary of the Commissioner of Social Services shall be increased in the sum of \$1, 676, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the Commissioner of Social Services shall be \$48,534.

9. The salary of the County Auditor shall be increased in the sum of \$2,117, effective 45 days after adoption of this Local Law with a lump sum installment to be paid as soon as possible for the past services rendered from April 26, 1993, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to April 26, 1993, the annual salary of the County Auditor shall be \$38,048.

This Local Law shall become effective 45 days after adoption of same, during which time said Local Law is subject to a permissive referendum.




