**A LOCAL LAW AMENDING LOCAL LAW #2-96 ESTABLISHING A
CODE OF ETHICS FOR THE COUNTY OF NIAGARA**

RESOLVED, that a Local Law Amending Local Law #2-96 Establishing a Code of Ethics for the County of Niagara, so as to delete Section 14(6)(a) thereof and replace it with an amended Section 14(6)(a) be enacted by the Legislature of the County of Niagara, New York as follows:

SECTION 14. Sanctions

6. Debarment

a. Any person, whether or not a County officer or employee, who intentionally or knowingly violates any provision of this Code, shall be prohibited from entering into any contract with the County, for a period of 25 years.
