**A LOCAL LAW INCREASING THE SALARY  
OF THE COMMISSIONER OF SOCIAL SERVICES**

1. The salary of the Commissioner of Social Services for the year 2002 shall be set at Job Group XVII, Level 1, \$61,617, effective forty-five (45) days after adoption of the local law; for 2003, the salary shall be set at Job Group XVII, Level 2, \$64,617, effective January 1, 2003; for 2004, the salary to be set at Job Group XVII, Level 3, \$67,617, effective January 1, 2004; and for 2005, the salary to be set at Job Group XVII, Level 4, \$70,617, effective January 1, 2005.

This Local Law shall become effective forty-five (45) days after its adoption, during which time said Local Law is subject to permissive referendum.




