## A LOCAL LAW INCREASING THE SALARY OF THE TREASURER

1. The salary of the County Treasurer shall be increased from \$67,963 per year to \$72,102 per year commencing April 5, 2004; \$74,265 per year commencing 1/1/2005 and \$76,864 per year commencing 1/1/2006.

2. This Local Law shall become effective in accordance with the statutes of the State of New York.




