1. Purpose – The purpose of the Council shall be to help Niagara County achieve higher standards in solid waste reduction and recycling participation.
2. Council Established – There is hereby established a county council to be known as the Niagara County Solid Waste Management Council.
3. Membership – The Council shall be composed of nine (9) members, to be appointed by the Chairman of the Niagara County Legislature, subject to full legislative ratification, comprised of one (1) an elected official to represent public interest, one (1) an expert on Public Health, one (1) an educator of Environmental Science, one (1) from the private waste management/recycling field, one (1) Engineer/Scientist, one (1) representative from the Business or Financial Community, two (2) from private industries that generate significant amounts of waste or operate pilot programs for waste reduction, and one (1) Niagara County Environmental Science Coordinator.
4. Term of Office – The term of office for the appointive members shall be two (2) years, but of the members first appointed, their term shall expire December 31, 2009. Vacancies in office shall be filled for the unexpired term in the same manner as the original appointments.
5. Powers and Duties – The Council shall have the following powers and duties:

Advise the County Legislature on matters affecting the standards in solid waste reduction and recycling measures.

- A. Seek to enlist the cooperation and assistance of all local governments and municipal entities, within the County, including public authorities, commissions, and other public entities in the development and promotion of programs on an inter-municipality cooperation basis designed to institute and coordinate sound methods of reducing and recycling for the entire community.
 - B. In the development of programs and in the work of the council generally in carrying out the purposes of this title to engage in studies, surveys, investigations and to consult with the public or private agencies.
 - C. To prepare and distribute books, charts, pamphlets and other literature on matters of solid waste reduction and recycling.
 - D. To cooperate and coordinate with all county, state and federal departments and agencies having jurisdiction in matter relating to solid waste reduction and recycling.
6. Compensation and Expenses – Unless otherwise provided by resolution of the County Legislature, the members of the Council shall receive no compensation for their services.
7. Subject to the approval of the County Attorney, this local law shall take effect immediately upon filing with the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law.


