WHEREAS, the Niagara County Legislature recommends the adoption of the following Local Law:

A Local Law Adjusting the Salaries of Niagara County Coroners

WHEREAS, a public hearing was held on October 21, 2008 at 6:30 p.m. in the Legislative Chambers, Courthouse, Lockport, New York, on said Local Law, and

WHEREAS, no one appeared to speak on said Local Law, and

WHEREAS, no amendment(s) was (were) made to said Local Law, now, therefore, be it

RESOLVED, that a Local Law of the County of Niagara for the year 2008 adjusting the salaries of the Niagara County coroners' be enacted by the Legislature of the County of Niagara, New York as follows,

1. That the salary of the Niagara County Coroners shall be adjusted as follows:
 - a. District #1, from \$22,473 per year to \$17,500 per year
 - b. District #2, from \$16,000 per year to \$17,500 per year
 - c. District #3, from \$16,000 per year to \$17,500 per year
 - d. District #4, from \$16,000 per year to \$17,500 per year

2. That such Local Law shall not take effect until forty-five days after its adoption by the Niagara County Legislature, nor until approved by the affirmative vote of a majority of the qualified elections of the County voting on a proposition for its approval if within forty-five days after its adoption there be filled, pursuant to Municipal Home Rule Law Section 24, a required petition. Upon adoption, the salaries adopted herein shall be effective and paid from January 1, 2009.
