CLAIM SETTLEMENT IN THE MATTER OF MARY A. ANNALORA, INDIVIDUALLY AND AS EXECUTRIX OF THE ESTATE OF GLENN T. ANNALORA VS. COUNTY OF NIAGARA AND JAMES R. VOUTOUR, NIAGARA COUNTY SHERIFF

WHEREAS, the County Legislature is authorized under Section 6-N of the General Municipal Law to approve claim settlements in excess of \$25,000.00, and

WHEREAS, on October 22, 2015, the Plaintiff and her late husband were involved in a fatal motor vehicle accident with a patrol car operated by a Niagara County Deputy Sheriff, and

WHEREAS, the case Mary A. Annalora, et al vs. County of Niagara and James R. Voutour, Niagara County Sheriff, went to mediation on June 21, 2017, where a settlement was reached after several hours of mediation thereby avoiding additional litigation, trial and a potential adverse judicial determination, now, therefore, be it

RESOLVED, that the authority to settle the case of Mary A. Annalora, et al vs County of Niagara and James R. Voutour, Niagara County Sheriff litigation, is hereby given to the Risk & Insurance Manager and the Niagara County Attorney in the amount of \$2,750,000.00, and be it further

RESOLVED, that upon review and approval by the County Attorney’s Office and Special Counsel for the County, the County Manager be and is hereby authorized and directed to execute any and all settlement documents including but not limited to Stipulation of Discontinuance and voucher/check for \$2,750,000.
